**HOLD HARMLESS AND INDEMNIFICATION AGREEMENT
“HIGH RISK ACTIVITY”**

Not withstanding any insurance coverage which may be in effect, and in addition to any additional undertakings referred to herein, Applicant agrees at all times to protect, indemnify, and hold Shasta County Office of Education, its Board of Trustees, officers, members, representatives, agents, guests, invitee, and/or employees free and harmless, and to provide legal defense, from any and all liabilities, claims, losses, judgments, damage, demands or expenses resulting from the Applicant’s use or occupancy of the County Office facilities and/or the active or passive negligence of the Applicant or of the County Office of Education, its Board of Trustees, officers, members, representatives, agents, guests, invitee, and/or employees, specifically including, without limitation, any liability, claim, loss, judgment, damage, demand, or expense, arising by reason of:

1. the loss of or damage to any of the County Office facilities including any building, structure, or improvement thereon, or any equipment to be used therein;
2. the injury to or death of any person including, but not limited to, the officers, members, representatives, agents, guests, invitee, and/or employees of the Applicant or of the County Office of Education; or
3. damage to any property arising from the use, possession, selection, delivery, return, condition or operation of the County Office facilities. Applicant further agrees to reimburse the County Office of Education for all liabilities, claims, losses, judgments, damage, demands, expenses, fines, penalties, including reasonable attorneys’ fees imposed or incurred by the County Office because of the Applicant’s use or occupancy of the County Office facilities and/or active or passive negligence of the Applicant or of the County Office of Education, its Board of Trustees, officers, members, representatives, agents, guests, invitee, and/or employees.
