The Excel Academy is the K-8 Regional Behavior Program. Support services include mental health clinicians, behaviorists, on-site psychologist, and Behavior Consultants. All staff are well versed in trauma informed and restorative practices and have completed training in behavior modification as well received certification in interventions. Class size maximum is 12 students per class. Students receive the necessary support to develop strategies and skills for transition to less restrictive district environments. Excel Academy has 3-4 classrooms, a multi-purpose cafeteria and a completely fenced outside area, providing for student safety.

Excel Academy Mission Statement: Excel Academy provides a safe and supportive environment where students develop effective academic and behavioral skills. Students are empowered to achieve their full potential through inter-agency partnerships and collaboration with families.

School Facility Conditions and Planned Improvements

The Shasta County Office of Education takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort the Shasta County Office of Education uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the Shasta County Office of Education Facilities Department.

The Shasta County Office of Education maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order website provided by the California Department of Education funded K12HSN is used to ensure efficient service and that emergency repairs are given the highest priority. In addition, preventative maintenance is conducted on a regular basis. During the past three years, the interior of the EXCEL buildings were painted, and new flooring installed. Replacement sinks have been installed in the classrooms, and cabinetry has been installed in the classrooms for additional storage and security. Exterior painting/touch up is conducted annually as needed.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

Professional Development

Excel Academy: Four designated calendar in service days are used for Professional Development. Every Monday is a minimum day and professional development is provided. Areas of focus include ProACT , Curriculum/State Standards, Behavior strategies, Trauma and brain development, STEP Evaluation process and Life Space Crisis Intervention, Restorative Practices. The areas of focus were selected by staff need surveys as well as goal development. The monthly half day teacher days are used to meet the academic goals developed by the staff. Student data is analyzed and curriculum developed to meet the student needs/standards. Professional Development is delivered in a variety of ways. Teachers meet with expert coaches, DVD series, online courses, workshops, professional coaching. Due to COVID-19 restrictions, professional development was delivered through online means.
