2021-22 School Overview

The Shasta County Independent Study serves students who seek an educational alternative to a traditional seat-time based education. The school uses the instructional strategy of independent study to meet the educational needs, interests, aptitudes, and abilities of students in grades six through twelve.

Currently, there are five full-time teachers working with approximately 135 students. Students meet with their teacher for one-hour two times per week at either of two locations in Shasta County. The school's curricula are standards-based and courses are considered equivalent in quality to classroom instruction.

The school's mission statement is, "To develop educated and responsible citizens."

The school's vision statement is, "To offer flexible options for personalized learning to prepare students for college and career.

School Facility Conditions and Planned Improvements

The Shasta County Office of Education takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort the Shasta County Office of Education uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the Shasta County Office of Education Facilities Department.

The Shasta County Office of Education maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order website provided by the California Department of Education funded K12HSN is used to ensure efficient service and that emergency repairs are given the highest priority. In addition, preventative maintenance is conducted on a regular basis. The school has two sites; the largest is co-located on a Shasta County Office of Education campus with two other schools. This site consists of four classrooms, a multipurpose room, and an administrative building, which were built in 2005. The second site, is located on the Shasta College campus and consists of a single classroom building.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

Professional Development

Independent study teachers have many professional development opportunities throughout the school year. Staff participate in over 36 hours of weekly collaboration focused upon lesson study and classroom observations. A majority of our teaching staff are involved in supplemental grant opportunities such as Expository Reading and Writing (ERWC) and Google classroom. Staff have attended trainings on Common Core State Standards (CCS) and strategies for engaging students. Staff has been actively involved in the LEA's new STEP teacher evaluation process, which offer annual training opportunities for SMART goal development and improving teacher effectiveness. They have attended a full day professional development on our new on-line learning platform, Edgenuity. Teachers also had the opportunity for two full days of training from CUE educators to support student engagement and learning. Monday collaborations have continued this year (20-21) with a focus on distance learning, analyzing assessment DATA to inform instruction, and using Google classroom and technology tools for building student engagement and collaboration.
