#### Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

## Percentage of Students Meeting or Exceeding the State Standard on CAASPP

Additionally, parents may participate on the combined School Site Council or District Advisory Committee; Juvenile Court School staff does participate on the combined School Site Council and District Advisory Committee and are involved in the development of school goals, strategies for improvement, as well as, action steps for the Single Plan for Student Achievement. Parents participate in Student Study Team meetings and Individualized Education Program (IEP) meetings. Also, parents have access to a Career Coordinator and a high school counselor for assistance in developing knowledge about career and college readiness. Upon enrollment of a new student, the school Principal sends a letter to the student's parents or guardians explaining how to contact the school staff and administration and offers to provide transcripts or schedule a school conference upon request. JCS holds parent meetings in and outside of the facility. This year, due to Coronavirus restrictions, we will hold an online forum for families.

The Juvenile Probation Department maintains a comprehensive safety plan that outlines emergency protocols, including disaster and evacuation plans. All permanent and substitute staff must participate in an orientation to the building, including a review of contingency and emergency protocols. The school staff and probation staff work together to provide a safe school environment for students, with constant communication between teaching and probation staff. Each class has a maximum enrollment of 17 and is staffed with a teacher and a para-educator. Additionally, there is a Resource Specialist Teacher who serves students on IEP's in the school.
