4.2.1. Credentials and Oaths for Temporary Certificates - Board Member Gorman wanted an explanation of what SCOE's role is in approving credentials, why the board needs to approve them, and what oath they take.

Associate Superintendent Hillman explained that we have a credentials analyst in our Human Resources office. The county office is required to act on behalf of school districts. We have some credential monitoring responsibilities. Protocols have been put in place by the Commission on Teacher Credentialing for short term, temporary certificates. We verify that the candidates meet the criteria to be given the certificates.

Board Member Mills explained that a principal/superintendent of a small school district may send a teacher to the county to get cleared to teach a specific subject. A lot of times it is the only way the administrators can fill a position.

Associate Superintendent Freeman read the Oath from the California Commission on Teacher Credentialing website.

# 6. <u>DEPARTMENT UPDATE/PRESENTATIONS</u>

6.1. Youth Support Services - Part 1

Austin Preller, Executive Director - Youth Support Services, provided the department update. He highlighted the Foster Youth Services Coordinating Program. Cynthia Vengley and Cheryl Harlow are leading this work. The program provides support to foster youth and districts. There are 612 foster youth in Shasta County jurisdiction. Shasta County is 2-3 times higher in substantiated child abuse and neglect than the state average. We support over 400 foster youth students from Shasta County and other counties. There are three levels of support that we provide are for districts, Shasta County Children's Services, and students and families.

He shared that Assembly Bill 740 created a drastic change in the department and districts. On January 1, it updated the education code by requiring a foster child's educational rights holder, attorney, and social worker have the same rights as a parent or guardian in terms of receiving notices from school.

A few celebrations that Mr. Preller highlighted, included the Foster Youth Education Summit that includes the largest team from Shasta County attending the conference. The Foster Youth graduation rates are steadily increasing. There is a private event for Foster Youth and their resource families at the Planetarium Event.

Challenges included the stability rate where only 53.9% of Foster Youth started and ended the school in the same school. They are moving around a lot. Assembly Bill 740 is another challenge in the tracking of social worker changes, working with other counties in processing Foster Youth, and the training of school districts.

Education of Homeless Children and Youth (EHCY) is another program within Youth Support Services. Maggie Joyce, Coordinator of Youth Support Services, is leading this work. This is similar to the Foster Youth services that we provide but for Homeless students. It is challenging to identify these students since a majority of the students qualify under shared housing. We provide support for districts and the students and families.

Mr. Preller shared some celebrations and challenges for this program. Celebrations include three families served in the Motel 6 program, seventy food boxes distributed, a homeless management information system license, and a new coordinator. Challenges are transportation and the one percent vacancy rate in Shasta County.

The Legend Charter School item was moved since it was 3:08 pm when the department update was finished.

### 7. LEGEND CHARTER SCHOOL

#### 7.1. Presentation

Nate Fairchild, Director of Science and Charter School Authorization, introduced the Legend Charter School and explained that this was the first hearing. There will be a training on April 19 to fully inform the board on what they need to consider in authorizing a countywide benefit charter school. The executive summary will be posted on April 25 for review and a decision will be made by the board on May 10.

Gina Murphy and Michelle Kuehl shared a presentation on Legend Charter School. Gina explained that this concept is based on her student teaching experience when she attended Delta College. Her professor ran a school for the homeless where the teaching and resources were brought to them. She learned that all needed resources can be accessed in one place.

Legend Charter School will have a large support staff. They will provide services that the districts cannot provide. Classrooms will include a general education teacher, special education teacher, and two classified paraprofessionals. Class size will not be larger than 20 students. Social Emotional Learning, Science of Hope, Restorative Practices, and Integrated Learning Strategies will be utilized. They will also incorporate alternative approaches which will include animal care, Biofeedback, Social Skills Education, and health and nutrition.

Their plan is for the school to open first to Transitional Kindergarten through third grade and continue to roll up. They are currently looking for a facility. There is a non-profit funder who would be willing to help once they have an authorizer.

### 7.3. Board Priorities

7.3.1. Literacy: Scarborough's Reading Rope & Getting Reading Right

Stephanie Byars, Literacy Coordinator, and Trudy Pellizzari, Director of District and School Support, presented the literacy update. They provided a review on the Science of Reading and Scarborough's Reading Rope. The rope is the basis of all of the literacy training that they are providing.

The Getting Reading Right Consortia includes goals to improve the reading achievement for all students. These goals include building teacher knowledge of Science of Reading, changing teacher practices, and sharing vetted resources. SCOE supports and provides the information for Transitional Kindergarten through fifth grade. The Los Angeles County Office of Education provides the training for sixth through twelfth grade.

Tanya Randolph and Kelly Smith, instructional coaches from the Shasta Union High School District, shared how they are supporting the Professional Learning Community (PLC) process. They support the reading teachers in any way they can. During the first semester, they saw student growth between 1-4 grade levels. In May they are evaluating and planning for next year.

### 7.3.2. Mental Health: Funding for Mental Health including Medi-Cal

Joy Garcia, Senior Director Special Projects, explained the funding from the state that is being provided around a whole child approach. The whole child approach includes expanded and early learning, connection to social services, connection to health and mental, and broadband and technology. The factors with the strongest predictors of academic success are mental health, early learning, socio-economic factors, and physical well-being. There are several integrated student supports funding being provided by the state. These investments have specific roles for the county office of education.

# 8. PROCLAMATION

### 8.1. Strengthening Families Collaborative

Associate Superintendent Freeman shared that the Board of Supervisors approved a proclamation announcing March the Aces, Resilience and Hope Awareness Month. This work is coming out of the Strengthening Families Collaborative. He represents the Shasta County Office of Education on the Collaborative. The recommendation is to follow the others in our community by approving it. We are partnering with a long list of community organizations.

Board Member Gorman proposed an edit. In the last line delete "Redding" since we are the County Board.

Board Member Manuel commented that it was an unusual proclamation in that it never declares March as the month in the final paragraph.

### 9. ACTION

9.1. Administrative Services

9.1.1. Second Interim Budget (2022/23)

Adam Hillman, Associate Superintendent of Administrative Services, reviewed the second interim budget. Our budget is in excellent shape. We are scheduled to receive the largest COLA increase since 1979-80, above 8%. It allows us to make a meaningful adjustment to our salary schedule and benefit package. We have settled with two of the groups.

Notable changes in the budget that he reviewed included:

- Unrestricted surplus increased approximately \$800,000 over the first interim.
- LCFF increased \$425,000 mostly due to the adjustment of differentiated assistance.
- State revenue increased primarily due to transportation increase.
- Increased our capital outlay primarily for the HVAC project that we are doing at the EXCEL campus.
- Salary savings due to vacancies.
- Restricted programs now have an estimated net surplus of \$43,000.
- The ending fund balance is healthy and allows us flexibility. We are setting aside \$1.3 million to purchase buses. Over a seven-year period it will be paid back from the districts.
- Deferred maintenance went down by \$400,00 because of the corresponding offset for the HVAC units.
- Restricted programs were increased with new funding from grants.
- Multiyear projection in the next two years we are showing surpluses of 2.8 million and 4.8 million.
- There will be big changes for SELPA and special ed due to funding for mental health services going directly to districts and charter schools.
- There is 7.5 million in our fund balance earmarked for facilities. We have not specifically designated that for the annex being explored across from the Professional Development Center. It still needs to be discussed in detail with the board. Regardless of where, more space is needed for the staff we have in place.
- ECS's deficit is due to the remaining capital outlay associated with the new building project.

### **10. STUDENT BOARD MEMBER REPORT**

Ava Gebhart, Foothill High School

Student Board Member Gebhart shared that the following things are happening at Foothill.

### 11. SUPERINTENDENT'S REPORT

11.1. Public Disclosure of Proposed Collective Bargaining Agreement - CSEA

Superintendent Flores explained that the board is not involved in negotiations. However, she was sharing the information since the proposed agreement needs to be made public. The proposal aligns with the COLA that the state has put out. The tiered health and welfare benefits cap has not changed since 2012-13. The benefits cap will be rebenched and SCOE will pay 80% instead of 50%. There will not be a fiscal impact to the current year, since it begins in the 2023/24 fiscal year.

The board participated in a FranklinCovey Training last week. We have used eight FranklinCovey books over the years. They are an international leader in leadership training. The purpose of the Great Boards Training is to build systems to engage our community in initiatives where we can positively impact student outcomes, accelerating student success countywide. We will receive the training over a two to three-year process.

Since the last board meeting, Superintendent Flores has been able to:

- Speak to the Retired Teachers Association and Leadership Redding.
- Spent a day with new county superintendents.
- Visited the Shasta Historical Society for "Her Side of the Story" Reception.
- Spoke a variety of issues at California Practitioners Advisory Group (CPAG).
- Toured R-STEM with board members.
- Toured ECS and discussed partnerships with Miguel Rodriguez of Shasta County Health and Human Services
- Visited four preschool classrooms with Brandy Groves.
- Attended the annual SCOE Bowling night.
- Attended board meetings for Children's Legacy Center, NorCal Education Leadership Collaborative Advisory Board, Western Educational Equity Assistance Center Advisory Board, and Simpson University Teacher Preparation and Credentialing Advisory Board.
