SUBJECT: SHASTA COUNTY BOARD OF EDUCATION AREA 2 VACANCY

The Shasta County Board of Education is accepting applications from qualified candidates to fill a vacancy in Area 2.

Eligibility

Candidates must reside in one of the following Area 2 elementary school districts: Bella Vista, Black Butte, Cascade Union, Castle Rock Union, Columbia, Cottonwood Union, Fall River Joint Unified, French Gulch-Whiskeytown, Gateway Unified, Happy Valley Union, Igo-Ono-Platina, Indian Springs, Junction, Millville, Mountain Union, North Cow Creek, Oak Run, Pacheco Union, or Whitmore Union

Pursuant to Ed. Code 1006(a) any registered voter is eligible to be a member of the county board of education except the county superintendent of schools, members of their staff, or any employee of a school district. Therefore, if those named applied and were appointed to the Shasta County Board of Education they would have to resign from their position prior to being sworn-in. This would also apply to any district governing board member.

Time Commitment

Regular meetings of the Shasta County Board of Education are typically scheduled for the second Wednesday of the month (except June) at 1:30 p.m. The June meeting is held on the fourth Wednesday to allow time for budget preparation. It is occasionally necessary to call Special Meetings or Study Sessions of the Board outside the Regular meeting schedule. The Shasta County Board of Education also serves as the Shasta County Committee on School District Organization.
