# 5. BOARD INITIATIVES

5.1. Substance Abuse Prevention

Austin Preller, Executive Director Youth Support Services, and Jen Cobb, Youth Support Services Coordinator, provided information on Substance Abuse Prevention. They shared what they have done, data trends, this new school year, and future opportunities.

In the past year, 5th-12th grade students have received classroom based education with presentations on vaping and fentanyl/prescription drugs. Professional Development has been offered through the Shasta County Prevention Summit, YVAPE Intervention Curriculum, Stanford Triangulum Conference, Stanford Tobacco Toolkit Training, Spring Into Action event, and various speakers. Student Engagement has been provided through intervention and cessation classes, on-campus lunch events, and referral posters. Parent Engagement has included movie theater and Facebook Ads and Spring Into Action event. Community Partnerships include the Tobacco Education Coalition and Shasta Substance Use Coalition.

The data trends for vape use and alcohol and drugs was varied. It showed a decrease in use of vape products in both middle and high school. There was a better understanding about the harm of vaping, and an overall increase in quit attempts. The numbers for the use of alcohol or other drugs are up. Parents report "lacking enough knowledge" as their main issue in keeping them from talking to their children about drugs.

A couple of new partnerships have been established this year. We have a marijuana education partnership with Shasta County Public Health. Also, increased community Partnerships with Hill

Country and Shasta Community Health Center.

There are several future opportunities. They include peer education, pending grant applications, Elevate Youth California, increased parent engagement, awareness campaigns, emphasis on alcohol education, and law enforcement partnerships.

# 5.2. Literacy

Rebecca Lewis, Executive Director Professional Learning and Leadership Support Services, and Stephanie Byars, Director District and School Support, presented information on literacy work underway that is aligned with the Board Initiative. They shared the current data and how literacy impacts every area of our life. There is a high percentage of students who cannot read that fail to graduate high school, are incarcerated, or on welfare. 95% of students are cognitively capable of reading. However, less than 40% are proficient in reading.

"Getting Reading Right" is a teaching program that is helping to build knowledge in the science of reading for teachers and paraeducators. The North State Reading Consortium has been formed through the collaboration of Shasta, Siskiyou, Butte, and Glenn Counties. Shasta County has participating staff in 14 districts.

They shared ways that the community can support this effort and what Reach Higher Shasta Literacy Committee is doing. Ways for the community to support included reading to children, participating in community literacy activities, supporting books drives, and participating in the Shasta County Literacy Conference Community Event. Reach Higher Shasta is helping with the conference and a training opportunity, as well as working on K-2 data collection.

Board Member Webb asked what the board can do to support this program. Ms. Byars suggested showing up for local literacy events, Reach Higher Shasta, grant work, helping to spread the word, financial support, encouraging family engagement, and spreading the word through social media and friends on the importance of reading.

# 6. **DEPARTMENT UPDATE**

# 6.1. Professional Learning & Leadership Support Services

Rebecca Lewis, Executive Director Professional Learning and Leadership Support Services, and Shere DePaoli, Senior Director Professional Learning and Leadership Support Services, shared about their branch of Instructional Services. They explained the support that they offer the districts, schools, and educators. It includes professional learning, networks, resources, regulatory support, and continuous improvement. The California System of Support and the different levels of support offered were also discussed. Fourteen Shasta County districts qualified last year for the level 2 differentiated assistance support.

Program highlights shared included Positive Behavior Interventions and Supports, PBIS. Shasta County is the California PBIS Region 2 Technical Assistance Center. Hands-on science is offered through Whiskeytown Environmental School, Schreder Planetarium, and STEM Career Day. Learning Communities for Native Success Grant has provided lesson development, learning opportunities, family liaison connectors, and activities for native youth and families.

The two 2022-23 department goals were service and culture. Service was focused on building relationships and providing proactive and responsive support to schools and districts. The second goal

was to cultivate culture with expressions of gratitude and appreciation toward one another and our collective impact.

# 13. SUPERINTENDENT'S REPORT

Superintendent Flores shared the following:

- The countywide first week of school enrollment is up by 381 students, a 1.5% increase.
- SCOE hosted the State of Education event where the Report to the Community was released. It was an event to help the community understand and highlight the work we are doing with

students and families, and share ways they can get involved. There were short presentations on literacy, preschools, Student Mental Health, the Native Grant, Science Programs, and Community Schools. Sixty five members of the community attended.

- Early Childhood Services received a visit from CDE. Joy Garcia, Brandy Groves and Renee Menefee took them on tour.
- Superintendent Flores was a panelist for West Ed to talk about the work SCOE is doing to increase engagement with our Native Students. The webinar was attended by 260 people. She shared ways that they can work with their partners.
